Glossary of Terms

Area A: It's the area, in which the Israeli army has pulled out fully and Palestinians hold all responsibilities for internal security and public order, including planning-related jurisdiction. This area represents 17.7% of the West Bank total area.

Area B: Palestinians have full control over civil administration, including planning-related jurisdiction and Israel continues to have overriding responsibility for security. This entails that the Israeli authorities have the privilege to intervene in any related Palestinian spatial planning activities, where they can stop or restrict any needed local spatial development as purported for security reasons, as have been the case in many instances. This practically makes area B an area C (See below). Nevertheless, area B represents 18.3% of the West Bank total area.

Area C: Palestinians have responsibility for civil life, including socio-economic aspects of education and health, while, the Israeli authorities assume full control over security and administration related to this area, including planning-related jurisdiction. This area represents 61% of the West Bank total area. The remaining 3% of the West Bank was designated in Sharm Al-Sheik Agreement (2000) as Nature Reserve. The Nature Reserve area is mainly located in Bethlehem and Hebron city-regions. This area has been handed over to the Palestinians only on papers, but in reality it remains under the effective control of the Israeli authorities.

Separation Barrier: It is the Separation Wall built by Israel. In urban areas it is a concrete wall up to 8 meters high, but more commonly a system of fences, barbed wire and ditches. It makes accessibility between places in Area C difficult for Palestinians and restricts land for development.

East Jerusalem: It is the territory that has been illegally annexed by Israel after it was captured in the 1967 war, and it is not part of Areas A, B or C.

J1: Includes that part of Jerusalem which was annexed forcefully by Israel following its occupation of the West Bank in 1967.

J2: Includes Jerusalem Governorate except that part of Jerusalem which was forcefully annexed by Israel following its occupation of the West Bank in 1967.

Planning Status

Data Collection & Plan Preparation: Plan is in preparation by a private planning bureau, conducting field studies, data collection and creating planning scenarios. First verbal discussions about the extent of the Master Plan take place.

Technical Discussion: Master Plan is handed over to the ICA in written form and gets revised by different technical committees (Defense, tourism, roads and water, sewage, etc.).

Public objection: Master Plan is announced for public objection for a time period of 60 days. Public objections are collected and discussed after the time period, adjustments to the plan might be necessary.

Final approval: All objections were discussed and taken into consideration. The plan is finally approved as legal basis for implementation of any construction and infrastructure.

Progressing: A Master Plan is advancing the ICA planning procedures.

Stuck: A Master Plan has legal constraints which could be solved by time or might be followed by rejection.


Foreword

I am pleased to introduce this new publication that documents the spatial planning efforts in Area C of the occupied West Bank. Since 2008, the State of Palestine Ministry of Local Government has been working closely with partners from the international community to support Palestinian communities to prepare local outline plans for their localities, not as a reaction, but rather as an action, a development tool and as a basic human right for communities, to plan their spaces and futures in a full participatory manner. So far, about 110 local outline plans have been prepared with and for 119 Palestinian communities, and 95 of them have been submitted to the Israeli authorities, but unfortunately only 3 local outline plans have been fully authorized - until October 2016- despite the fact that the prepared plans meet international quality standards, as testified by international planning experts commissioned by the United Nations Human Settlements Programme last year.

MoLG will continue its efforts to cover the Palestinian communities in Area C with spatial plans to enable spatial development and functionally link the rural communities in Area C with the Palestinian urban centers in Area A and B. The publication at hand provides an excellent documentation to the plans prepared and this is helpful for policy-makers, advocates, academia, and the other interested parties.

Finally, I would like to thank the European Union and the United Kingdom, and the implementing partners, UN-Habitat, and the Applied Research Institute-Jerusalem for their support.

Introduction

The West Bank, under the Oslo Accords, was divided into 3 zones: Area A, B, and C. Area A, which is made up of the Palestinian city centers (excluding part of Hebron city) is under Palestinian civil and security control. Area B, which is made up of the Palestinian built-up areas outside Area A, is under Palestinian civil control and joint Israeli and Palestinian security control, though Israel has exclusive right to enter Area B to conduct “security operations” as it wished. Area C, which makes up 61% of the West Bank is under Israeli civil and security control. These area designations were meant to be temporary, with land being transferred to the Palestinian control by the end of the five-year interim period as designated by the Oslo Accords, which was set to end with final status negotiations in 1999.

Area C is rich with natural resources. It also contains about 60% of agricultural lands in the West Bank and includes permanent crops, arable lands, heterogeneous agricultural lands and plastic houses. Some 300,000 Palestinians currently live in Area C. The majority of Palestinians (some 2.3 million) currently live in Areas A and B; both of which constitute 39% West Bank’s landmass. Hence, Area C has the potential for significant urban expansion to accommodate Palestinian population growth and economic development needs. Furthermore, this area has many touristic and archaeological sites, water resources from water wells and springs, Dead Sea minerals and salts, and stone (including marble) deposits.

In spite of its acknowledged importance for sustainable development in Palestine and for the establishment of a sustainable Palestinian State, the Palestinian Authority has no security or administrative control over this area. Rather, Area C is under the jurisdiction of the Israeli Civil Administration (ICA). As of 2015, Israeli military zones occupied 29% of Area C, and Israeli settlements occupied 6% of Area C and these continue to spawn and expand. An additional 3 percent of land was designated as nature reserves areas to be transferred to the control of the PA. However, this transfer of control never materialized. Palestinian communities living in Area C therefore find themselves marginalized, often without access to basic services, without adequate schools or clinics, and sometimes even without water or electrical networks.


Area C includes the Jordan Valley and areas declared as “state land”. Planning and zoning are under full Israeli control. The Jordan Valley is one of the most important agricultural areas in Palestine. Its year-long warm climate and fertile land is crucial for the production of food for Palestine’s growing population and for turning a profit on agricultural exports; and its extensive uninhabited sections make it attractive for development in terms of energy, infrastructure and industry. Furthermore, economists think that the Jordan Valley needs to be opened to the Palestinian population immediately enabling realization of the potential for economic development in this region, which is crucial to the rehabilitation and development of the Palestinian economy in order to ensure the viability and sustainability of the future Palestinian state.

In recent years, Area C has emerged as a key priority for the PA the international actors in the development sector operating in the oPt. The development potential of Area C has been acknowledged to be critical to the viability of the Palestinian State and the success of the two-state solution by those actors who are now increasingly more interested to empower existing Palestinian communities to preserve their assets, way of life, and most importantly their continued presence on the land. As the current division of the West Bank has the over-urbanized and densely populated Areas A and B forming a patchwork of “isolated islands”. This patchwork of “isolated islands” and inaccessibility of Area C for development jeopardizes the sustainability of the Palestinian economy and the viability of any future Palestinian State. A viable Palestinian State can thus only be achieved by opening Area C for Palestinian development and for the critical realization of a contiguous Palestinian State.

Analysis of Population Densities in the West Bank

The total area of the West Bank excluding East Jerusalem is (5,579 km²). There are 2,618,191 Palestinians living in 734 communities in the West Bank (excluding East Jerusalem) compared to 486,000 settlers living in 181 Israeli settlements. There is a stark contrast between the Israeli settlers and the Palestinians in their access to living space and natural resources. The Net Palestinian Population Density (population/built-up area) is approximately three folds (or 300% higher) than that of the Net Israeli Population Density. When comparing the two populations in Area C; the Net Palestinian Population Density is 250% higher than the Net Israeli Population Density. In Area C, the Palestinian population density is 6,818 (person/km²) compared to 2,793 (person/km²) Israeli settlers. High population densities have been associated with environmental problems such as air pollution, lower living standards (e.g. lack of access to green urban spaces) and congestion. The contrast between the living standards between Israeli settlers and Palestinians is just

one of the few injustices Palestinians suffer from the Israeli ICA restriction on development in Area C open spaces.

The contrast in accessing the living space and resources between Palestinians and Israeli in Area C is even larger when comparing population densities within the areas allotted for development (i.e. master plans). The Palestinian population density within the proposed master plans in Area C is almost 600% higher than the population density for Israeli settlers in the settlements' master plans. This is part of Israeli plans to facilitate expansion and development of settlements while restricting the Palestinian potential for development in Area C.

Currently, the Palestinian population density per area of proposed master plans in Areas C is much higher than the Palestinian population density per area of approved master plans in Areas A and B. The high Palestinian population density within the master plans of Area C means there is little space for population increase, provision of essential services, and utilization of land for agriculture or any other resource for economic development. Restricting development of Palestinian communities' results in migration of Palestinians to urban centers and villages in Areas "A" and "B" which can be viewed as a part of Israeli policies to depopulate the Palestinian population in Area C on route to complete Israeli control of this area. Figure 1: Population Density in West Bank and Area C




Figure 2: Population Density in Local Outline Plans in Area C



Status of Planning in Area C

Since 2008, the MoLG in partnership with the local communities began drafting their own detailed Local Outline Plans in Area C. As of August 2016, 110 plans have been drafted for 119 communities of which 96 have been submitted to the ICA.

The planning process and negotiation with the ICA is coordinated by the GoP and MoLG. This marks a significant policy change of the MoLG in terms of the engagement with the ICA mainly to respond to the planning inequalities resulting from the restrictive planning practices. The outline plans were developed to comply with ICA planning criteria. The ICA requires that the plans do not include lands for agriculture and other development purposes, because of their interpretation of the Jordanian Planning Law of 1966 which states that these detailed Outline Plans' are only designed for built-up areas. Furthermore, these plans took into consideration the geographical distribution of Israeli settlements, the West Bank Separation Barrier, and other constraints imposed by Israel such as closed military zones, Israeli-designated nature reserves and archaeological sites. In spite of these plans being developed to comply with ICA planning criteria, only 3 of the 96 submitted plans were approved by the ICA; 7 were rejected for reasons including location in firing zone, a nature reserve or others. Another 70 plans have passed more than 18 months of technical discussions with the ICA without decision, noting that 8 of them have been published for public objection. The remaining 15 plans entered the review process by the ICA less than 18 months ago. There are also 14 outline plans in the data collection and preparation phase.

These community-led plans are supported by the MoLG and funded by members of the international community. They take into account population growth and internal zoning of future built-up areas to the extent possible.

The available types of local outline plans in the West Bank could be categorized into two main categories according to the initiating party, namely:


- Palestinian outline plans:** initiated, papered, and approved by the Government of Palestine through the Higher Planning Council mainly in Areas A and B of the West Bank. The process of preparing these plans started right after the inception of the PA, and the first approved plan was in 1996.
- Israeli special (partial) outline plans:** initiated, prepared, and approved by the ICA. The process started in the 1980s covering the entire West Bank territory and ended in Areas A and B in 1995, after the inception of the PA.

Since 1996 until March 2015, the PA has approved 149 local outline plans in Areas A and B of the occupied West Bank, according to the statistics of the planning department at MoLG. In addition, there are 79 plans published for public objection according to the statistics of the GIS department of MoLG (*GeoMoLG*).

The table and figure below show the progress in the approval of outline plans by the PA since 1996 per governorate:



One can notice that the bulk of approved plans at 63 percent have been approved after 2006. This period has privileged from increased donor support to the PA as a confidence building measure after the second Intifada. Nevertheless, the period after 2011 has witnessed a relatively small percentage of approved outline plans at less than 28 percent, arguably due to the PA focus on preparing outline plans in the Israeli occupied Area C of the West Bank.



A worthwhile note to be made here is that the dates of approval for the outline plans of the main Palestinian cities of the West Bank are relatively old, as illustrated in the table here:

One should notice as well that the cities of Hebron and Bethlehem (including Beit Jala and Beit Sahour) do not have yet an authorization on the updated outline plans.

The outline plans prepared by the PA can also be classified according to their progress status: Fully Approved; Published for Objections; and Under Preparation


More factual information:

- These outline plans cover only a total area of (487.669 Km²), which represents 8.6 percent of the total area of the West Bank, and 24.1 percent of the total area of Areas A and B that effectively fall under the Palestinian planning jurisdiction.
- The outline plans serve a population of 1,405,619 capita, which represents about half (50%) of the total population of the West Bank.
- The number of special (partial) outline plans in the West Bank (according to GeoMoLG) is 168 plans, with a total area of 46.83 Km², representing 0.8% of the total area of the West Bank.

This publication contains maps for 60 proposed outline plans, 36 of which are detailed plans that specify areas for residential zones, public facilities, archaeological sites, green areas, and commercial and industrial zones. The remaining 24 outline plans contain the proposed local outline plan boundary, known as the blue line and the extent of the built-up area as of 2014.

The 36 detailed outline plans had a total area of 27,919 dunums classified as: residential (49.40%); public facilities (17.40%); archaeological sites (1.32%); green areas (31.21%); and commercial and industrial (0.67%). (Figure 4: land use type classification for 36 plans).

Map 2: Spatial plans in Area C




This publication is organized into 9 sections corresponding to the governorates for which outline plans could be published at this stage. Hebron governorate had the highest number of available outline plans where Nablus and Tubas Governorates had only 1 outline plan. For the 2 Governorates Ramallah and Tulkarm, no detailed local outline plans are available to be published at this stage.

Jerusalem Governorate

Jerusalem Governorate (Arabic- 'Al Quds') is located in the central highlands region between the Mediterranean Sea and the northern edge of the Dead Sea. As a region, Jerusalem covers a total land area of 344,452 dunums (344.4 km²), More than 95% of the Governorate is classified as Area C which is exposed to the occupation restrictions.


There are 38 localities in Jerusalem Governorate. 10 of these localities are within East Jerusalem, the so called "J1 boundary" that was illegally annexed by Israel in 1967. Since after, these 10 localities continued to suffer from shortages in services and social infrastructure due to the planning regime administered by the Israeli authorities. The remaining 28 localities are outside the J1 boundary, within the so called "J2 boundary". The Palestinian built-up areas constitute 10% of the total area of the Governorate. According to the PCBS the total population of Jerusalem Governorate in 2007 was 363,649 people, representing approximately 15.47% of the total population of the West Bank.

Since 1996 until March 2015, the PA has approved 18 outline plans in Area B in the Jerusalem Governorate, the number of approved outline plans in the Governorate represent 12% of the total number of approved outline plans in Areas A and B within the West Bank.


This percentage is almost the same for the approved outline plans in the Governorates of Hebron and Tulkarm.

Among the 18 outline plans that were approved by the PA in Area B, 8 were approved between the years (1996-2000), another 8 outline plans were approved between the years (2001-2005) whereas only 2 outline plans were approved between the years (2005 to 2011).

In addition to these approved 18 outline plans in Jerusalem Governorate, there are 4 outline plans for localities within Area C that were submitted to the ICA. The 4 plans are still under progressing; 1 out of them is in the public objection stage, while the other 3 are still in the technical discussion stage. It is worth noting that the ICA issued more than 2,800 demolition orders in Jerusalem Governorate (excluding east Jerusalem). 102 demolition orders were located within the boundary of the proposed outline plans. Therefore, the approval of the proposed 4 outline plans is necessary to reduce or eliminate the risk of demolition of the threatened structures.



Al Khalayleh



Community Description

Al Khalayleh is a Palestinian community in Jerusalem Governorate located 1.5km west of Al Jib village. Al Khalayleh local outline plan was funded by the Government of Belgium. The plan total area is 348.61 dunums; so far, Al Khalayleh community received 57 demolition orders by the ICA.



According to the 2013 IPCC census, the total population of Al Khalayleh was 556; of whom 53% are males and 47% are females. There are 104 families living within 103 housing units.


Village Boundary





Hebron Governorate

Hebron Governorate is located 36 km south of the city of Jerusalem, in the southern part of the West Bank. It is bordered by the Bethlehem Governorate to the north and the 1949 Armistice Line (Green Line) in all other directions. Hebron governorate covers a total land area of 592,815 dunums (592.82 km²). More than 46.7% of the Governorate is classified as Area C which is exposed to the occupation restrictions


There are 56 localities in the Hebron Governorate, broken down into 96 geographical areas and 56 administrative areas. It is noted that Palestinian built-up areas constitute 8% of the total area of the Governorate. According to the PCBS, Hebron Governorate's total population in 2007 was 552,164 people; forming approximately 23.6% of the West Bank's total population.

Since 1996 until March 2015, the PA has approved 18 outline plans in Areas A and B of Jerusalem Governorate, the number of approved outline plans in the Governorate of Hebron represent 12% of the total number of approved outline plans in Areas A and B of the West Bank. This percentage is comparable to the number of approved outline plans in the Governorates of Jerusalem Tulkarm and is higher than the corresponding percentages in the other governorates.

Among the 18 outline plans that were approved by the PA in Areas A and B, One was approved between the years (1996-2000), another 5 outline plans were approved between the years (2001-2005), and 9 outline plans were approved between the years (2006-2010) whereas only 3 outline plans were approved between the years (2011 to 2015).

In addition to these approved 18 outline plans in Hebron Governorate, there are an additional 31 outline plans for localities within Area C. The 31 plans are still under progressing; only 1 was fully authorized; 2 are in public objection stage; 16 are in the technical discussion stage; while the other 11 Local Outline Plans and 1 Regional plan are still in the data collection and plan preparation stage.

It is worth noting that the ICA issued more than 3,257 demolition order in Hebron governorate. 314 demolition orders were located within the boundary of the proposed outline plans. Therefore, the approval of the proposed 31 outline plans is necessary to reduce or eliminate the risks of demolition of the threatened structures.



Masafer Yatta Regional Development Plan


As a means of supporting Palestinian communities living under the threat of forced displacement and house demolitions, UN-Habitat and their local partner, IPCC launched a pilot initiative to prepare a regional plan targeting 18 localities and detailed outline plans for 12 localities in Masafer Yatta inside the Firing Zone 918. 6 localities were benefited by the preparation of a proposed outline plan's boundary (blue line, that was not further detailed). The project started in 2013, and was carried out in cooperation with the MoLG, and was funded by the French Government. The project proposed plans of three scales: regional, cluster and local.

The regional development plan was particularly beneficial due to the limited population numbers in individual localities, as well as their physical fragmentation despite the strong functional connections. The plan specifies the main services and functions on a regional scale, as well as the expansion areas for each individual locality.


The regional plan covered an area of 36,000 dunums, and took into consideration the historic zoning and landuse set out in the British Mandate plan RJ5; the location of nature reserves; and the current landuseplan, in addition to the results of 5 community visioning workshops.

In one of the community visioning workshops it was suggested that the area should be a bio-medical touristic area, with a touristic corridor/route leading to the Dead Sea. The regional plan shows the suggested touristic path passing through the area as indicated on the map.

The plan also designates land for agricultural use, which can be cultivated. One key issue Masafer Yatta suffers from is the scarcity of water; as a solution, the plan proposes a water cistern that will serve the entire area of Masafer Yatta.

Bethlehem Governorate

Bethlehem Governorate is located to the south of the city of Jerusalem, in the southern part of the West Bank. It is bordered by the Hebron Governorate to the south and southwest, the Dead Sea to the east, and the Armistice Line (the Green Line 1949) to the west.

As a region, Bethlehem covers a total land area of 659,111 dunums (659.1km²). More than 70% of the Governorate is classified as area C which is exposed to the occupation restrictions


There are 35 localities in the Bethlehem Governorate, broken down into 45 geographical and administrative areas. It is noted that Palestinian 'built-up areas' constitute 3.6% of the total area of the Governorate. According to PCBS, Bethlehem Governorate's total population in 2007 was 176,235 people; forming approximately 7.5% of the West Bank's total population.

Since 1996 until March 2015, the PA has approved 6 outline plans in areas A and B of Bethlehem Governorate, the number of approved outline plans in the Governorate of Bethlehem represents 4% of the total number of approved outline plans in Areas A and B of the West Bank.


Among the 6 outline plans that were approved by the PA in Areas A and B, 2 were approved between the years (1996-2000), another 2 outline plans were approved between the years (2001-2005), and 1 outline plan was approved between the years (2006-2010) whereas only 1 outline plan was approved between the years (2011 to 2015).

In addition to these approved 6 outline plans in Bethlehem Governorate, there are 25 outline plans for localities within Area C that were submitted to the ICA. The 24 plans are still under progressing; only 1 was fully authorized; 2 are in public objection stage; 21 are in the technical discussion stage.

It is worth noting that the ICA issued more than 1,084 demolition orders in Bethlehem governorate. 354 demolition orders were located within the boundary of the proposed outline plans. Therefore, the approval of the proposed outline plans is necessary to reduce or eliminate the risks of demolition of the threatened structures.


There are 14 localities in the Tubas Governorate, broken down into 20 geographical areas and 14 administrative areas. It is noted that Palestinian built-up areas constitute 1.5 % of the total area of the Governorate. According PCBS, Tubas Governorate's total population in 2007 was 49,489 people; forming approximately 2.1% of the West Bank's total population.

Since 1996 until March 2015, the PA has approved 5 outline plans in Areas A and B of Tubas, the number of approved outline plans in the Governorate of Tubas represent 3.5% of the total number of approved outline plans in Areas A and B of the West Bank.


Among the 5 outline plans that were approved by the PA in Areas A and B, 1 was approved between the years (1996-2000), another 1 outline plans was approved between the years (2006-2010), whereas 3 outline plan were approved between the years (2011 to 2015).

In addition to these approved 5 outline plans in Tubas Governorate, there are 5 outline plans for localities within Area C that were submitted to the ICA. The 5 plans are still in the technical discussion stage.

It is worth noting that the ICA issued more than 206 demolition order in Tubas governorate. 65 demolition orders were located within the boundary of the proposed outline plans. Therefore, the approval of the proposed four outline plans is necessary to reduce or eliminate the risks of demolition of the threatened structures.



Al 'Aqaba



Community Description

Al 'Aqaba is a Palestinian community in Tubas Governorate located 4.7km north east of Tubas City. Al 'Aqaba local outline plan was funded by the United Kingdom and the EU. The planning total area is 407.89 dunums; 62% of which is classified as residential; so far, Al 'Aqaba community received 47 demolition orders by the ICA.



According to the 2007 PCBS census, the total population of Al 'Aqaba was 104; of whom 54 are males and 50 are females. There are 23 families living within 20 housing units.

Al 'Aqaba is located within Tayasir village boundary. 89.5% of the village boundary is located within Area C, whereas 8.2% and 2.3% are located within Areas A and B respectively. In addition to Al 'Aqaba community there are 2 Palestinian communities (Al Malih and Tayasir) located within Al 'Aqaba village boundary.
